**Self Drive (non operated) Hire**

- 1 The Hirer shall indemnify the owner in accordance with clauses 8, 12 and 13 of the CPA Model Conditions for all loss or damage, howsoever caused and subsequent loss of hire.
- 2 The Hirer is responsible for all daily checks such as tyres, tracks, oil and water levels and daily greasing. Failure to carry out checks may cause component failure which could result in chargeable repairs.
- 3 Plant must be returned in a clean condition.
- 4 All damage is chargeable.
- 5 Any operator using the plant must be assessed as competent to do so.

**Plant Supplied with operator (operated plant)**

- 1 The Hirer shall indemnify the owner in accordance with clauses 8, 12 and 13 of the CPA Model Conditions for all loss or damage, howsoever caused and subsequent loss of hire
- 2 Plant must be returned in a clean condition.
- 3 All damage is chargeable, in particular all punctures or other tyre damage.
